If the individual cannot obtain one online for whatever reason, it must be obtained by completing and checking box 7 on the IRS Form 4506-T, Request for Transcript of Tax Return, and mailing it to the IRS. If appropriate, a similar confirmation from another taxing authority (e.g., a U.S. territory or a foreign government) is also acceptable. Dependent students are able to fill out the Student Non Tax Filer form from Western instead of getting the letter from the IRS. Contact the Financial aid office to get the form.
